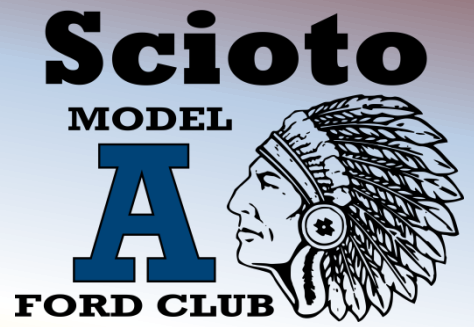

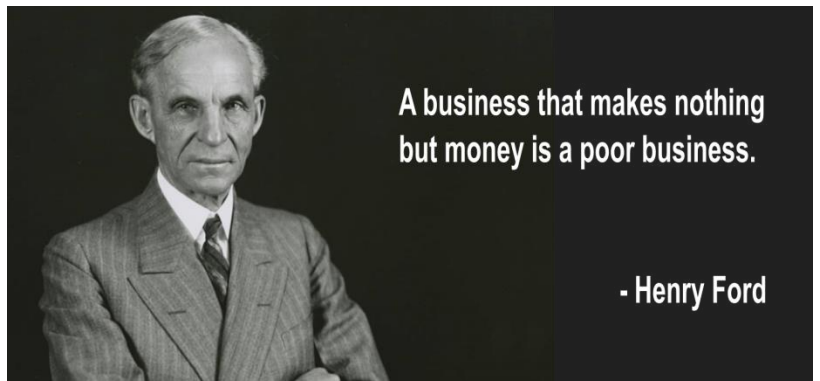

President Garn then turned the meeting over to Elections. He was happy to reveal that our Vice President, Jaci Rohner, will become our President for 2022.

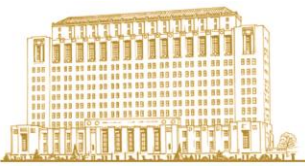
Since Wayne Davis was the only person nominated for the Vice President position, he was elected to the position and will assume the duties in January.

GENERAL VISITOR INFORMATION

- The Court now requires that all employees and visitors in the Judicial Center **must wear masks inside the building**, regardless of vaccination status.
- Please let Dan know in advance if you will require special assistance. There are several wheelchairs available in the building.
- Please remember that you will be visiting a work environment.
- Out of respect to the tour guides, visitors are asked to refrain from using their phones during a tour (other than when taking photos).
- Photography is permitted during the tour except in the courtroom when court is in session. Visitors are also asked not to take photos of the security screening area as they enter the building.

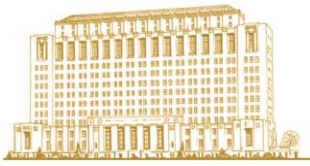
BUILDING SECURITY

- The Supreme Court of Ohio is a secure building. All adult visitors are subject to security screening. This is a process similar to going through airport security.
- Building security staff determines how visitors will enter the building. It is possible that visitors dropped-off on Civic Center Drive will be escorted to the Front Street entrance.
- Visitors are encouraged to travel light – cell phones, tablets and other metal objects can slow down the screening process.
- If entering through Civic Center Drive, please press the intercom button to alert security staff of your arrival.

Arriving on Time

- If you will be more than 15 minutes late for your tour, your tour may be shortened.
- We often have more than one group visiting each day and cannot make last minute adjustments to the schedule. Please do not arrive more than 15 minutes early for your tour. Guides are scheduled to lead your tour at the agreed upon time.

DIRECTIONS & PARKING GARAGES

DRIVING DIRECTIONS

From the North:

Take 71-S to I-670 (exit 109A); go west and follow to Third Street (exit 4B). Take Third Street about five blocks to State Street. Turn right onto State Street. Follow State Street two blocks to Front Street. Turn right onto Front Street. The Thomas J. Moyer Ohio Judicial Center will be on the left side of Front Street.

From the South:

Take 71-N to 70-E. Stay on the right. Exit at Front Street/High Street (exit 100A). Turn left onto Front Street. The Moyer Judicial Center is about five blocks on the left.

From the East:

Take 70-W to 71-N (exit 101A); exit immediately at Broad Street (exit 108B). Take Broad Street to Third Street. Turn left onto Third Street. Follow Third Street for one block to State Street. Turn right onto State Street. At second light, turn right onto Front Street. The Moyer Judicial Center will be on the left side of Front Street.

From the West:

Take 70-E to the Front Street/High Street exit (exit 100A). Turn left onto Front Street. The Moyer Judicial Center is about five blocks on the left.

BACKYARD TECH TIP



OIL WEIGHT?

Pick the weight of the engine oil by the condition of the engine (oil pressure) & the outside temperature. Many folks use 30w detergent all year. A straight weight oil is probably ok in a hot climate, but you will get excessive engine wear on startup in cold climates. (That's one reason multi-vis oil was invented). A work engine is going to need a heavier weight oil to maintain oil pressure at operating speed & temperature. Many people use 10w30, 15w40 or even 20w50. Some like the newer diesel rated oil because of the additives for the flat tappets & they highly recommend using Shell Rotella T 15w-40. You may need to increase the weight if the engine has low oil pressure.

1920 Winter Coats - Part 1

The decade began with long wool velour overcoats that featured oversized details: Big collars, big cuffs, large buttons, huge pockets, and matching belts. Some had detachable fur collars for extra warmth and luxury. Most of these coats came in neutral dark colors such as blue, brown maroon, grey and hunter green.

The ample fit made women appear smaller underneath. They also provided room for the layering of warm clothes, an important matter in an age of indoor heating and frequent travel by foot, train or bus.

Full belts that centered around the high waist were common in the early '20s, as well as for collegiate or trench-style coats. The length hovered around mid-calf, showing a bit of skirt and tall lace-up or button-up boots below.

FLAPPER of the MONTH



This month we feature Constance Talmadge. Last month we featured her sister, Norma Talmadge. Constance was blonde; Norma was brunette. She was buoyant and a comedienne; Norma was introspective and a tragedienne. Nicknamed "Dutch" because she looked like a Little Dutch Boy, Constance was one of silent pictures' most popular and enduring stars of romantic comedy. Constance was born in Brooklyn in 1898. After her sister had become a commodity for Vitagraph Studios, Constance, in her early teens, begged to follow. Constance's first comedy short for was in 1914 for Vitagraph. As the two sisters were as different as night and day, professional jealousy never entered into the picture. She grew so much in stature that she eventually formed her own production company. Constance, as did sister Norma, abruptly left films with the advent of sound. The notion that they willingly abandoned their careers while very much on top does not quite ring true. Both she and Norma's pronounced and rather squeaky Brooklyn accent did not prove all that suitable for talkies and it's more likely that they left Hollywood on their own terms before they were shunned. Both sisters invested wisely in business ventures in later life. Married four times, Constance became reclusive and fell victim, as did her sister, to alcohol abuse in later years. She died of pneumonia in Los Angeles on November 23, 1973.
